

**AREA AGREEMENT
NORTH CENTRAL FOOTBALL LEAGUE
AND
WIMMERA FOOTBALL NETBALL LEAGUE**

Junior Competition Permits Only

A reciprocal Area Agreement between the North Central Football League and the Wimmera Football Netball League to allow an interchange of registered players from the North Central Football League clubs to play with Wimmera Football Netball League clubs, or for Wimmera League players to play with North Central Football League clubs – without clearance or permit subject to the following conditions.

This agreement is signed pursuant to the current AFL Vic Country Rules and regulations pertaining to clearances and permits and in particular the Rule 2.10 – Area Permits, whereby an interchange of players between clubs of the abovementioned Leagues may take place without clearance or permits and is subject to any provisions contained within this agreement.

Provided However;

1. This agreement shall apply for season 2022.
2. That the players involved desire to play with the club in either League on the day in question.
3. The clubs involved are agreeable to the players playing on the day in question.
4. The players concerned are acquainted with AFL Vic Country Rules 2.1 and 2.5 regarding One day permits to Major Leagues and eight matches.
5. That prior to each match played the player shall obtain written permission to do so, from his parent club. The permit shall be processed online (via PlayHQ), like a one-day permit form, and dispersed by the club with which the player plays on the

day, as required under Rule 2.1 of the AFL Vic Country Rules and Regulations. All parties must approve the permit request before the player is eligible to play, as required under Rule 2.1 of the AFL Vic Country Rules and Regulations.

6. Players of any club having a bye will not be allowed to play with another club on that day, unless they have previously played with that club in the current season under this agreement. The club playing the player from the other League shall show his registered club on the match team sheet. Also provided that junior players are not eligible to play with another side when their club has a bye regardless of whether they have previously played a game with another club.
7. That players shall not be permitted to play more than eight matches with other clubs under the provisions of this agreement.
8. That no club play more than two players in each grade on the one day with the exception of junior age players where each club may play three junior age permit players and provided that each N.C.F.L and W.F.N.L club is limited to granting three permits from their club each week to play in the other junior competition.
9. Except for juniors, players cannot play with more than one club in either League, save as provided for under Rule 2.2.
10. That a player, having played eight matches with the other club, shall be required to obtain a full clearance to be able to continue to play with that club under similar conditions as set out in AFL Vic Country Rule 2.
11. No permits to be used in finals.
12. That this agreement cannot be altered unless agreed to by the Area Manager.
